The Meeting came to order at 5:50 PM by Mayor Kneib who called for roll call which was recorded as such:

COMMENTS FROM TOWNSHIP COMMITTEE & COMMITTEE REPORTS

Mayor Kneib commented that each Committee person has the same "power" no one individual has more "power" than the other. Committee serves all of Pennsauken, and that each Committee member has different committees they oversee. They all work collectively for the Township of Pennsauken it doesn't matter if your Democrat, Republican or Independent it's for ALL of Pennsauken.

Committeeman Killion commented that he would hope that when they are of age they would consider becoming involved in public service. He also commented that people call with various problems if you can solve them you're a hero and if you can't residents are usually still appreciative of the call back and some guidance.

Committeewoman McBride commented on the different types of commissions the Township has for residents to get involved with if they aren't interested in running for public office. "There's always some type of committee/commission to that may interest you"

Mayor Kneib explained that the biggest frustration for Committee at this point is vacant housing, but that the numbers are slowly but surely coming down. He again gave the student an opportunity to ask any questions..... they declined.

Committeewoman McBride moved the motion to adjourn Committeeman Killion seconded the motion.
