MEMORANDUM OF UNDERSTANDING TO TRANSFER VEHICLE FROM THE TOWNSHIP OF PENNSAUKEN TO THE BOROUGH OF BERLIN

TO THE BOROUGH OF BERLIN

This document constitutes a Memorandum of Understanding (“MOU”) entered into by and between the Township of Pennsauken, a body politic and corporate of the State of New Jersey located at 5605 North Crescent Boulevard Pennsauken, NJ and the Borough of Berlin, located at 59 South White Horse Pike Berlin, NJ. The date of execution of this MOU is the 10th day of June, 2019.

WHEREAS, the Borough of Berlin hereinafter, (“Berlin”) has procured by has requested that the Township of Pennsauken to; allow Berlin to assume ownership of a vehicle, more particularly described as a 2003 Ford Expedition (VIN FMPUI6W63LA75045) for Office of Emergency Management purposes, and;

WHEREAS, the Township of Pennsauken has agreed to transfer title to the vehicle and use of the vehicle by Berlin subject to compliance with various conditions outlined below.

Now, Therefore, in consideration of the mutual covenants and conditions hereinafter set forth the parties agree as follows:

The referenced vehicle shall be titled to the Borough of Berlin, and utilized by Berlin Borough subject to the following conditions:

Vehicle is transferred in an “as is” condition without express or implied warranties and comes with no loose equipment.

Vehicle must be maintained and repaired as appropriate by Berlin Borough.
Vehicle odometer reading is 79,090.00 miles as of 06/01/2019.

2. In the failure to satisfy the conditions set forth above in Paragraphs 1.a, 1.b and 1.c, the vehicle shall immediately be transferred back to the Township of Pennsauken and no longer be utilized by Berlin Borough with no claim to any ownership interest in the vehicle by Berlin.
3. The Borough of Berlin shall hold harmless and indemnify the Township of Pennsauken from any and all claims relative to its ownership and use of the vehicle.
4. This memorandum of understanding represents the entirety of the agreement between the parties.
