AN ORDINDANCE OF THE TOWNSHIP OF PENNSAUKEN AMENDING CHAPTER 101, "ANIMALS" AND SECTION 101-6 ENTITLED "FEES"TO FURTHER REGULATE VICIOUS DOGS

WHEREAS, there exist the need to keep track of dogs through registration, and

WHEREAS, a list of dogs in the Township deemed "vicious" or potentially dangerous by the municipal courts, will be forwarded to the Municipal Clerk's office once determined; and

WHEREAS, each dog owner must register their pet(s) each year; and

WHEREAS, any person applying for a license and registration tag for a dog determined to be vicious or potentially dangerous pursuant to N.J.S.A. 4:19-23 et seq. of the laws of the State of New Jersey shall pay an annual fee of \$700.

NOW, THEREFORE BE IT ORDAINED, that Chapter 101 Animals, Section 101-6 Fees is hereby amended to add subsection "C" in accordance with the following:

101-6

C. Any person applying for a license and registration tag for a dog determined to be vicious or potentially dangerous pursuant to N.J.S.A. 4:19-23 et seq. of the laws of the State of New Jersey shall pay an annual registration fee of \$700.

REPEALER, SEVERABILITY AND EFFECTIVE DATE.

- A. <u>Repealer.</u> Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. <u>Severability.</u> In the event that any clause, section, paragraph, or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.
- C. <u>Effective Date.</u> This Ordinance shall take effect upon proper passage in accordance with the law.

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF PENNSAUKEN, COUNTY OF CAMDEN, STATE OF NEW JERSEY, AUTHORIZING AND APPROVING A FINANCIAL AGREEMENT BETWEEN THE TOWNSHIP OF PENNSAUKEN AND LIBERTY TERMINAL AT PENNSAUKEN URBAN RENEWAL, L.L.C. FOR PROPERTY KNOWN AS BLOCK 201, LOT 4, PURSUANT TO THE LONG TERM TAX EXEMPTION LAW (N.J.S.A. 40A:20-1 et seq.)

WHEREAS, Township of Pennsauken (the "Township") is a municipal corporation of the State of New Jersey, located in Camden County; and

WHEREAS, Liberty Terminal at Pennsauken Urban Renewal, L.L.C. (the "Entity") is the owner of Block 201, Lot 4, on the official Tax Map of the Township (the "Property"), located in the Waterfront Redevelopment Area of the Township ("Redevelopment Area"); and

WHEREAS, the Entity will design, finance, and construct a new storage facility for petroleum storage and distribution, including related site improvements to the property, such as upgrades to storage tanks, the storm water management system, above ground piping and pumps, the guard booth, and a new operations control building (the "Project"); and

WHEREAS, the Long-Term Tax Exemption Law of New Jersey, N.J.S.A. 40A:20-1, et. seq. ("Long Term Tax Exemption Law" or "LTTE Law") permits a municipality to enter into a financial agreement exempting real property from tax assessment and accepting payments in lieu of taxes; and

WHEREAS, the Township is authorized to provide for a tax exemption within the Redevelopment Area and for payments in lieu of taxes ("PILOTs") in accordance with the Local Redevelopment and Housing Law, *N.J.S.A.* 40A:12A-1, *et seq.* ("Redevelopment Law") and the LTTE Law; and

WHEREAS, the Township has received the Entity's written application ("Application") pursuant to the LTTE Law, for approval of a tax exemption for the proposed improvements as part of the Project (the "Improvements"); and

WHEREAS, the Township has received a form of Financial Agreement ("Financial Agreement") with the Entity's Application, providing for payments in lieu of taxes, a copy of which is attached to this Ordinance as **Exhibit A**; and

WHEREAS, the Pennsauken Township Committee ("Township Committee") has determined that the exemption from taxation and annual service charges in lieu of taxes pursuant to the terms in the Financial Agreement allows and encourages the Improvements to the Property, and is, therefore, in the best interest of the Township and is in accordance with the provisions of the Long-Term Tax Exemption Law and the public purposes pursuant to which the Project has been undertaken; and

WHEREAS, the Pennsauken Township Committee ("Township Committee") deems it in the Township's best interest to authorize an Ordinance for the Township to enter into the Financial Agreement with the Entity under the terms provided in the Financial Agreement, attached as Exhibit A, as well as to grant a tax exemption:

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Pennsauken, County of Camden, and State of New Jersey, that the Township will enter into a Financial Agreement with the Entity on the terms and conditions stated in the Financial Agreement attached to this Ordinance and as further set forth herein:

- 1. The Township Committee makes such determinations and findings pursuant to and in conformity with the Long-Term Tax Exemption Law.
- 2. The Project is hereby approved for the grant of a tax exemption pursuant to and in conformity with the Long-Term Tax Exemption Law.
- 3. The Financial Agreement, including all attached exhibits and schedules, are hereby authorized, and approved.
- 4. The Improvements shall be exempt from real property taxation, and the Entity shall pay the Township an annual service charge in lieu of real property taxes, for the duration of the term and under the provisions outlined in the Financial Agreement.
- 5. A certified copy of this Ordinance and the Financial Agreement shall be transmitted to the Department of Community Affairs, Director of the Division of Local Government Services, only after adoption of this Ordinance and the execution of the Final Agreement.

BE IT FURTHER ORDAINED that the Mayor of the Township of Pennsauken is hereby authorized to execute the Financial Agreement and any additional documents as are necessary to implement and carry out the intent of this Ordinance and the Financial Agreement.

AWARD OF CONTRACT FOR THE RENOVATION OF SKATEPARK PENNSAUKEN TOWNSHIP MUNICIPAL SERVICES DEPARTMENT BID PACKET # 21-10

WHEREAS, the Township Committee of the Township of Pennsauken has determined a need for the Renovation of the Township Skatepark Bid Packet No. 21-10, same being more particularly described in specifications which are on file in the Office of the Township Finance Department and available for public inspection during regular business hours; and it is appearing that the cost of the aforementioned renovation will be paid with municipal funds and will exceed \$44,000 in a fiscal year; and

WHEREAS, there has been public advertisement for bids, and the Township Purchasing Agent has received and opened bids on October 19, 2021 for the purpose of awarding a contract for the aforementioned renovation and the Township Director of Municipal Services has advised the Township Committee that a certain entity is the lowest, qualified, responsible bidder for said contract and has recommended that the Township Committee award said contract or reject the bids within sixty (60) days as required by N.J.S.A. 40A:11-24;

WHEREAS, the Chief Financial Officer of the Township of Pennsauken, as required by N.J.A.C. 5:30-1, has certified that there are sufficient funds available for the purpose of awarding a contract to said entity, said certification being attached hereto and made a part hereof.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Pennsauken, County of Camden, State of New Jersey, as follows:

- 1. The Township Committee, based upon the aforementioned certificate, hereby declares that there are sufficient funds available for the aforesaid purpose, as is evidenced by the attached Certificate of Availability of Funds.
- 2. That the Township Committee, for the aforementioned reasons, hereby declares that American Ramp Company, 601 S. McKinley Ave, Joplin, Missouri 64801 is the lowest, qualified responsible bidder for the aforementioned renovation project and hereby authorizes an award of contract to said entity for the aforesaid purpose in an amount not to exceed \$657,000, in accordance with the terms and conditions of the Bid Proposal, the Notice to Bidders, and Bid Specifications, copies of which are on file in the Office of the Township Finance Department and available for public inspection during regular business hours.

RESOLUTION TO OPT IN TO EXAMINATION EXEMPTION CIVIL SERVICE HIRING PROCEDURES

WHEREAS, the Township of Pennsauken, Camden County, State of New Jersey (hereinafter referred to as the "Township") is a jurisdiction governed by Title 11A and the Civil Service regulations and rules established under Title 4A of the Administrative Code; and

WHEREAS, P.L.2021, C7 permits municipalities to hire police officers who may nothave taken an open competitive examination for the title of Police Officer, but are otherwise duly qualified, have completed training, and hold a valid NJ Police Training Commission Certificate as Police Officer (Basic Course for Police Officer); and

WHEREAS, recently adopted State legislation, Bill S-3220, approved as P.L.2021, C.7, would permit a municipality to exempt any person for an entry-level law enforcement person from taking the Civil Service law enforcement exam, as long as they have completed the full Basic Course for Police Officers training course at a school approved and authorized by the New Jersey Police Training commission; and

WHEREAS, the legislation would also require that a municipal or county police department may hire a person under this exemption only upon adoption of a conflict of interest and nepotism policy; and

WHEREAS, The Township has duly established written policies governing nepotism and conflicts of interest; and

WHEREAS, in order to effectuate this policy, a municipality must affirmatively "opt in" by adopting a Resolution authorizing such a hiring policy; and

WHEREAS, Chief of Police Philip Olivo recommended that the Township effectuate this policy and "opt in" to this program in the interests of efficiency, expediency, and the promotion of public safety within the Township; and

WHEREAS, this "opt in" provision shall remain valid until changed by a rescinding resolution of the Governing Body.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Township Committee of the Township of Pennsauken for the reasons set forth above that the Township hereby authorizes such hiring policies related to the examination exemption as set forth in Bill S-3220, P.L.2021,
