Pursuant to N.J.S.A 40A:11-23c, Addenda may be issued for the bids. It is the sole responsibility of the respondent to be knowledgeable of all addenda related to this procurement. If bidders obtain a bid from the website, it is their responsibility to check the website and purchasing department prior to the bid opening to see if addenda have been issued. Copies of addenda or notice of same will be made available on the Township Website or will be faxed or sent via U.S. Mail to all registered vendors, bidders who pick up bid specifications from the Municipal Building or receive specifications from the Municipal Building or receive specifications by mail will automatically receive copies of addenda. ### **General Submission Requirements**

### **Submission of Bids**

The Township of Pennsauken, Camden County, New Jersey (hereinafter referred to as "Township") invites sealed bids pursuant to the Notice to Bidders.

Sealed bids will be received by the designated representative at the time and place stated in the Notice to Bidders, and at such, time and place will be publicly opened and read aloud.

The bid form shall be submitted in a sealed envelope: (1) addressed to the Township;

- (2) bearing the name and address of the bidder written on the face of the envelope; and
- (3) clearly marked: "BID" with the bid # and title of the bid.

It is the bidder's responsibility to see that bids are presented to the Township on or before the hour and at the place designated. Bids may be hand delivered or mailed: however, the Township disclaims any responsibility for bids forwarded by regular or overnight mail. If the bid is sent by overnight mail, the designation in section C, above, must also appear on the outside of the delivery company envelope. Bids received after the designated time and date will be returned unopened.

Sealed bids forwarded to the Township before may be withdrawn upon written application for the bidders who shall be required to produce evidence showing that the individual is or represents the principal or principals involved in the bid. Once bids have been opened, they must remain firm for a period of sixty (60) calendar days, which time may be extended in accord with law.

All prices and amounts must be written in ink or preferably typewritten. Bids containing any conditions, omissions, unexplained erasures or alterations, items not called for in the Bid form, attachment of additive information not required by the specifications, or irregularities of any kind, may be rejected by the Township. Any Changes, white-outs, strike-outs, etc. on the Bid page must be initialed in ink by the person responsible for signing the Bid

Each Bid form must give the full business address of the bidder and be signed by an authorized representative. Bids by partnerships must furnish the full name of all partners and must be signed in the partnership name by one of the members of the partnership or by an authorized representative, followed by the signature and designation of the person signing. Bids by corporations must be signed in the legal name of the corporation, followed by the name of the State in which incorporated and must contain

the signature and designation of the president, secretary or other person authorized to bind the corporation in the matter. When requested, satisfactory evidence of the authority of the officer signing shall be furnished.

Bidders must insert prices for furnishing all the materials, services and/or labor required by these specifications. Prices shall be net, including any charges for packing, crating, containers, etc. All transportation, charges shall be fully prepaid by the Lessee for delivery to the destination and 4 placements at locations specified by the Township. As specified, placement may require inside deliveries. No additional charges will be allowed for any transportation costs resulting from partial shipments made at the vendor's convenience.

The vendor shall guarantee any or all materials and services supplied under these specifications. Defective or inferior items shall be replaced at the expense of the vendor. In case of rejected materials, the vendor will be responsible for return freight charges.

The Township of Pennsauken is exempt from and State sales tax or Federal excise tax.

Public funds may use to pay only for goods delivered or service rendered. The Township will not pay penalties and/or interest on overdue bills. No employee is authorized to sign a letter of credit or any other document that represents a legal commitment on the part of the Township to pay additional fees.

Multiple bids not allowed. No bidder shall be allowed to submit more than one bid from an individual, firm, partnership, corporation, or association under the same or different name, this will be cause for automatic rejection of your bid.

### **Award**

The awarding will be unit price multiplied the estimated quantity. The estimated quantity is based off passed year; the ordering could be more or less for the year. The award will be on a line basis item.

# MANDATORY EQUAL EMPLOYMENT OPPORTUNITY LANGUAGE Goods, Professional Services and General Service Contracts (Mandatory Affirmative Action Language)

During the performance of this contract, the contractor agrees as follows:

The contractor or subcontractor, where applicable will, in all solicitations or advertisements for employees placed by or on behalf of the contractor, state that all qualified applicants will receive consideration for employment without regard to age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation or sex.

The contractor or subcontractor, where applicable, will send to each labor union or representative or workers with which it has a collective bargaining agreement or other contract or understanding, a notice, to be provided by the agency contracting officer, advising the labor union or workers' representative of the contractor's commitments under this act and shall post copies of the notice in conspicuous places available to employees and applicants for employment.

The contractor or subcontractor, where applicable, agrees to comply with any regulations promulgated by the Treasurer pursuant to N.J.S.A. 10:5-31 et seq., as amended and supplemented from time to time and the Americans with Disabilities Act.
