**You will need to provide the following items to complete the training**

- 1) A room large enough to safely and comfortably accommodate up to 25 employees.
- 2) A television with a DVD player, or a computer with a projector, screen, and speakers, shall be ready to operate in the room used for the training program. **If AV equipment is unavailable the fire department can provide this for an additional \$50.00 fee.**
- 3) One (1) fire extinguisher, having a minimum rating of 2A:20B:C, for every four (4) students will be needed for the live fire training program. One (1) fire extinguisher will be needed for the classroom session. **These fire extinguishers may not be taken from the required extinguishers in your facility.**
- 4) A suitable outdoor place on the business' property will be needed to conduct the live fire training. This area shall be 30 feet from all buildings and vehicles. **If a space cannot be obtained the fire department can provide the off-site space for an additional fee of \$100.00**
- 5) Several cardboard boxes to burn as a fuel for the live fire exercise.
- 6) A legible list of all employees attending the training must be given to the instructor at the time of the training session.
- 7) Class size shall be limited to no more than 25 employees.
- 8) A form will be signed by you approving the time and number of employees attending the training session.
