Discussion of Business in Redevelopment Areas presented by Terry Carr and Larry Cardwell

Recording studio – 4616 Westfield Ave *Bills Electronics store*) this occupancy certificate application is for a proposed recording studio.

Mr. Cardwell informed Committee they called and asked to be removed.

Habitat for Humanity – 7937 South Crescent blvd (*Howard Hill*) This location was formerly a furniture store. The perspective tenants would like to relocate an existing Habitat for Humanity to this site.

Mr. Carr stated Habitat for Humanity would like to lease the existing building the current operation has closed.

** Committee approved to move forward

OctaPharma – 5000 North Crescent Blvd. (next to DaVita Dialyses). The proposed operation deals with the public donor supply of blood plasma. See attached.

Mr. Cardwell presented the information and stated they would have 2 shifts with 25-30 personnel on site. The concern would be parking and safety buffering a neighborhood development.

There were two persons on the call to represent OctaPharma

<u>Patrick McNamara of Red Bank, NJ</u> stated a letter had been submitted prior to the Corona Virus. They are currently looking at plasma helping to cure victims of the virus.

Mr. Kerry Clish of Charlotte, SC commented on the safety aspect of the 111 facilities they currently own throughout the country. He assured Committee there would be no issue with security.

Committee asked several other questions concerning number of employees, number of anticipated participants, hours of operation, loitering and the assurance of quality of life to the neighbors.

**Committee is not ready to give approval to move forward and asked for additional written information

PUBLIC COMMENT

<u>Jack Killion of Bryn Mawr Avenue</u> – Gave his congratulations to Committee and their quick response to the pandemic. He stated he thought the monuments would be a nice addition to the Township. He commented that he was also happy to see the transfer of deeds.

<u>Chris Mateo of Corbett Avenue</u> is concern about the opening of Pennsylvania, Philadelphia specifically and the PA residents coming across the bridge to Pennsauken. He specifically asked if the Township was coordinating with the Mayor of Philadelphia on the safety of Pennsauken.

Mayor Killion replied that the Township is following the guidelines of the Governor here in New Jersey. We are aware of other states opening up, we have and are aware we have the 2nd highest numbers; the borders to our neighboring states are not closed; but we will continue to take precautions. We take our guidelines from the State. He also commented that he specifically is not in contact with the Mayor of Philadelphia but attends a conference call twice a week with the county and once a week with the Governor.

<u>Michele Gillis of Connecticut Avenue</u> – Questioned if the Township has heard anything more on the schools

Mayor Killion responded no, and that we probably will hear something in the upcoming weeks and directed her to the school website and Superintendent.

Deputy Mayor DiBattista moved a motion on close the floor to the public Committeewoman Rafeh seconded the motion An Affirmative 5/0 roll call vote

COMMITTEE COMMENTS

<u>Deputy Mayor DiBattista</u> thanked everyone who joined the meeting, he continued by stating how proud he is of the Fire, Police, EMS, OEM and Twp. employees who are all doing a great job. "Social distancing is working please continue to practice it."

Committeewoman Rafeh thanked those who joined the meeting and also thanked the Fire, Police, EMS, OEM Mayor and Committee. She commented that the Library has a lot of programs going on and stressed to check their website. Stay at home preschool story time with a bilingual Wednesday @ 6pm; Family read aloud Thursdays @ 7pm online also broadcast channel 19 on Comcast and channel 21 on Verizon; DIY Friday where adults can showcase their projects. There will be a seminar on keeping pest out of your garden. For these and other programs please reach out to quarantine@pennsaukenlibrary.org. She ended with a quote from Muhammed Ali "DON'T COUNT THE DAYS, MAKE THE DAYS COUNT"

<u>Committeeman Dyer</u> thanked the first responders and added Doctors, Nurses, Janitors, truck drivers and grocery store employees. "Pennsauken is doing a great job, but I'd like to ask everyone to continue your social distancing, wear your mask and protective clothing and to please check on your elderly neighbors and family."

<u>Committeewoman McBride</u> Commented she has a concern that the numbers will go up. She encouraged everyone to share checking in on neighbors. "The more we know about each other the more we can help" She reminded everyone of how important the census is and asked everyone to ask someone if they've completed their census form and encourage them to aske other to do the same.

<u>Mayor Killion</u> thanked the dynamic duo of social media Ryan Wachter and Frank Sinatra. He stated they have received lots of pictures and videos and encouraged everyone to please check it out on our social media pages. He asked everyone to continue to wear their mask. "I know everyone wants to go back to 'normal' but to please have patience." Go Birds.
