#### MINUTES TOWNSHIP OF PENNSAUKEN TOWNSHIP COMMITTEE MEETING NOVEMBER 19, 2020

The Committee Meeting of the Pennsauken Township Committee was held via ZOOM electronic participation on Thursday, November 19<sup>th</sup>, 2020.

The Meeting was called to order by Mayor Killion at 6:00 pm. An update was given on the number of Corona Virus cases to date in Pennsauken, which are up by 342 cases from the last meeting now totaling 1,592 cases total. He also reported the number of deaths at 29, up three in the last two weeks. Mayor Killion expressed his thoughts, concerns and prayers for families affected by the virus and families who have lost loved ones. He continues to stress the importance of wearing your mask, washing your hands and social distancing.

Mayor Killion called for the Salute to the Flag followed by a Moment of Silence requesting special thoughts and prayers for families affected by the virus and for members of the public with the difficult task of counting votes.

The announcement of the "Senator Byron M. Baer Open Public Meetings Act" was given keeping the meeting in compliance with state laws.

## IN RECOGNITION OF CHIEF MICHAEL COYLE PENNSAUKEN EMS FOR 42 YEARS OF FAITHFUL SERVICE

WHEREAS, it is with great reverence and appreciation that we gather today to honor Chief Mike Coyle for more than four decades of faithful service to the Pennsauken Emergency Services operation. Chief Coyle has been a dedicated and steadfast employee who has provided a critical service to the residents of Pennsauken. Today we recognize your commitment to this community and the impact you have made; and

WHEREAS, Mike began his career with the Pennsauken First Aid Squad as an EMT in 1978. By 1984 he was elected Captain, a position he would hold exclusively until 1995. Recognizing the need for a cohesive, cooperative and comprehensive program, Mike would lead the conversion of the First Aid Squad into the Pennsauken Emergency Medical Services initiative. Mike helped revolutionize the concept of this service by facilitating the transition of a mostly volunteer-based program to a fully paid and partially-paid career service; and

WHEREAS, in 1995 Michael Coyle would be named Chief of Pennsauken Emergency Services. He would maintain this role for the duration of his career. In addition to this position, Chief Coyle would serve as the EMS Coordinator for Camden County and as the Annex Director for the Pennsauken Office of Emergency Management. His response to the COVID 19 Pandemic has been vital, consistent and efficient. Chief Coyle maintained regular communication with the Medical Director at Cooper University Hospital as well as the New Jersey Department of Health Commissioners and as such was critical in disseminating information accordingly. Additionally, Chief Coyle was critical in helping to develop protocols for our municipal services, business community and residents to help keep Pennsauken as safe as possible; and

WHEREAS, Chief Coyle, along with his wife Debbie, have long been supporters of the PYAA Softball Program. They have dedicated countless volunteer hours to this community. Without their involvement, many of the Township events and programs would have been unsustainable. Chief Coyle is the proud father of Kelly and Bryon and although he has held several titles throughout his life, perhaps the most cherished of all is Pop Pop to Jade, Vito, Elizabeth, Leslie and Victoria.

**NOW, THEREFORE, I, Tim Killion, Mayor of Pennsauken,** along with the members of Township Committee hereby honor Chief Mike Coyle on a long and successful career at the helm of Pennsauken Emergency Services. Abraham Lincoln once remarked that "next to creating a life, the finest thing a man can do is save one." Chief Coyle has certainly experienced this during his tenure and for that, there are countless grateful individuals who lived to see another day. We thank you Chief for your service and dedication. We wish you a much deserved retirement filled with happiness and good health.

**Section 1.** The following unfunded appropriations remaining as balances in Bond Ordinance 2020-03 ("Bond Ordinance") heretofore adopted by the Township Committee on March 5, 2020 are hereby cancelled:

<u>Section 2.</u> The amount of \$30,000, which represents a portion of the unfunded appropriation cancelled from Section 7(A) of the Bond Ordinance described in Section 1 hereof, is hereby re-appropriated from said Bond Ordinance to Section 7(C) of said Bond Ordinance for the construction and reconstruction of various streets and roads in the Township as part of the Township's 2020 Road Reconstruction Program, all as more particularly described in the documentation on file in the Office of the Township

Administrator and available for inspection during normal Township hours, together with the acquisition of all materials and equipment and completion of all work necessary therefor or related thereto.

<u>Section 3.</u> The aggregate amount of \$75,000, which represents: (i) the remaining portion of the unfunded appropriation cancelled from Section 7(A) of the Bond Ordinance described in Section 1 hereof; and (ii) the unfunded appropriation cancelled from Section 7(B) of the Bond Ordinance described in Section 1 hereof, is hereby re-appropriated from said Bond Ordinance to Section 7(F) of said Bond Ordinance for concrete repairs and Improvements for various sidewalks, curbs, and other structures in the Township, all as more particularly described in the documentation on file in the Office of the Township Administrator and available for inspection during normal Township hours, together with the acquisition of all materials and equipment and completion of all work necessary therefor or related thereto.

<u>Section 4.</u> The remaining funded and unfunded appropriation balances as authorized by the Bond Ordinance shall be unaffected by this ordinance and shall remain available for the uses set forth therein.

<u>Section 5.</u> The average period of usefulness of the purposes referred to in Sections 2 and 3 hereof, within the limitations of the Local Bond Law and according to the reasonable life thereof, is not less than 6.42 years.

<u>Section 6.</u> The Capital Budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the amended Capital Budget and Capital Program as approved by the Director of the Division of Local Government Services, is on file with the Municipal Clerk and available for inspection.

<u>Section 7.</u> The improvements authorized hereby are not current expenses and are general improvements that the Township may lawfully make. No part of the cost of the improvements authorized hereby has been or shall be specially assessed on any property specially benefited thereby.

**Section 8.** All ordinances, or parts of ordinances, inconsistent herewith are hereby repealed to the extent of such inconsistency.

- 1. Any request to reschedule a confirmed wedding date/time that is prior to 24 hours of the original date/time will be honored for no additional fee.
- 2. Any requests to reschedule a confirmed wedding date/time less than 24 hours before that date/time will result in an additional fee of \$75.

## CANCELLATIONS

- 1. Cancellations for a wedding ceremony must be made 24 hours prior to the confirmed date/time for a full refund of the \$125 fee.
- 2. Cancellations made less than 24 hours from the confirmed date/time will receive a \$50 refund.

BE IT FURTHER ORDAINED, that all ordinances or parts of any ordinances inconsistent or in conflict with the provisions of the ordinance are hereby repealed.
