Line Drive Baseball Academy – 5811 South Crescent Blvd *between Schleicher & Frosthoffer Aves* (*Next to Top Notch Barbershop*) the perspective tenant would use this facility for a batting cage and sports practice. See attached letter of support from the High School Baseball coach.

Snapbox Self Storage – 6504 South Crescent Blvd *between Garden &Witherspoon Aves (formerly Metro Storage)* this is for a change of ownership from Metro Storage to SnapBox Self Storage.

** Mayor and Committee are fine to have them move forward

Clayton Gentry – 7490 South Crescent Blvd (*Supremos Lot near the corner of Central Highway*) the owner of the lot would like to build a new self-storage facility at the far end of the lot from the Century 21.

Representatives were present to present their plan to build a four story storage facility, after much discussion.

Committee told them of their concerns with the deteriorating shopping center.

Committeeman DiBattista had questions about the building height and parking. He commented that the security cameras are not a real traffic study and that he believed one would need to be completed.

Mayor McBride has concerns about parking.

Joanne Young of Park Ave. questioned why the use of the Doctrine of Necessity.

Township Solicitor Galella commented that they are not required to state why but that there are three members of committee who are members of the golf club.

Mr. Napieralski of Kirkwood, NJ talked about the Townships Ordinance 251 (Rentals) and commented his thoughts again on the Townships Ordinance.

Mayor McBride asked Mr. Napieralski if we could make copies of his back up paperwork so that we could all be on the same page. He commented only if it could be done in 5 minutes.

Lisa Eckel of Browning Road questioned when the Master Plan would be updated.

Mayor McBride commented that the last Master Plan was done 50 years ago with several re-exams done the last one in 2013. "It's a lengthy and costly project but one, we are looking into having done."

Committeewoman Rafeh commented information is being gathered.
